## ACTIVEPORT ACCELERATES GROWTH OF ITS GLOBAL EDGE PLATFORM WITH NBN

### Leverages Managed Networks services and Superloop infrastructure to increase gross margins on \$1.9M of annual revenue.

Activeport Group Ltd (ASX: ATV) ("Activeport" or "the Company") announces the integration of NBN circuit provisioning into its Global Edge network-as-a-service platform. Currently providing enterprise circuits through the Fibreconnx network in Sydney and Melbourne, Global Edge now extends national connectivity, enabling data access to virtually any location in Australia.

Introduced in June 2025, Activeport's Network as a Service platform, Global Edge, delivers self-service connectivity via Fibreconnx—the most adaptable enterprise solution in Australia for linking CBD offices in Sydney and Melbourne to key colocation data centres. The addition of NBN expands this platform's scope, allowing customers to establish connections across the country with enhanced efficiency and reach.

- **National Coverage Expansion:** The Global Edge portal supports self-provisioning of NBN services, providing comprehensive access throughout Australia.
- **Integrated Network Capabilities:** Combines Fibreconnx's scalable, on-demand bandwidth in high-density Sydney and Melbourne locations with NBN's broad national footprint.
- **Strategic Infrastructure Leverage:** Utilises Managed Network's NBN POI backhaul, underpinned by Superloop (and others') fibre for connectivity to 121 points of presence, enabling nationwide service without additional capital investment or operational overhead for Activeport.
- **Provisioning Automation:** Collaborates with the Managed Networks business to implement advanced APIs and automation for expedited NBN deployment and support.
- **Revenue Optimisation:** Migrates Activeport's 1,600 ISP customers from an off-net provider to Activeport's on-net NBN, improving margins by 25% on \$1.9M in annual revenue.
- **International Connectivity:** Links Global Edge to Activeport's Singapore Network-to-Network Interchange, enabling international telcos to procure circuits to any Australian destination.

#### Establishing a Robust International Network Gateway for Australia

Building on the successful rollout of Global Edge in Sydney and Melbourne via Fibreconnx, NBN integration extends coverage nationwide, allowing customers to connect to any location in Australia. Enterprises with distributed sites value unified network management for consistency and operational efficiency. By combining Fibreconnx's flexible bandwidth options with NBN's extensive reach, Global Edge facilitates the seamless migration of entire networks to a single, integrated platform.

Activeport specialises in international network orchestration, providing software that enables telcos and data centre operators worldwide to deliver self-service automation to enterprise clients. With this expanded coverage, Global Edge equips international carriers with streamlined tools to provision circuits originating overseas and terminating anywhere in Australia.

#### Peter Christie, Chairman and CEO of Activeport Group Ltd, stated:

*"The integration of NBN provides national coverage for our Global Edge platform. Comprehensive network access is essential to deliver a last mile service in Australia to our international carrier and data centre customers. We've accelerated deployment by leveraging Managed Networks' NBN expertise, allowing us to increase revenue generation capacity on our Global Edge network."*

Christie continued: *"Our goal is to position Global Edge as the premier solution for global telcos to acquire, integrate, and manage circuits between overseas origins and Australian destinations or vice versa. International operators often face challenges acquiring connectivity without strong local market knowledge; Global Edge addresses this by simplifying purchasing and automating network management."*

## Market Opportunity

The NBN presents a significant opportunity for Activeport's Global Edge platform, with NBN Co reporting \$5.7 billion in FY2025 revenue and 8.63 million active connections across 12.56 million premises passed—delivering near-universal broadband coverage to urban, regional, and rural areas in Australia. This infrastructure supports reliable national connectivity for enterprises with multi-site operations. For business users, NBN offers specialised wholesale products, such as business NBN Enterprise Ethernet, providing symmetric speeds and a 99.95% network availability commitment to meet demands for high-bandwidth applications, site integration, and secure data transport. Through this integration, Global Edge enables Activeport to address the increasing need for scalable, automated enterprise networking in Australia's evolving telecommunications sector.

NAB Investment Holdings, trading as Managed Networks operates a national carrier-grade network leveraging dark fibre, wavelength, and Virtual-NNI (V-NNI) services from multiple tier-one carriers to deliver a fully aggregated NBN TC4 wholesale backhaul solution.
