

Trade Me Group Limited to be removed from the S&P/ASX 200 Index

SYDNEY, APRIL 17, 2019: S&P Dow Jones Indices announced today that it will remove Trade Me Group Limited (XASX: TME) from the S&P/ASX 200, as a result of the scheme of arrangement whereby the company will be acquired by Titan AcquisitionCo New Zealand Limited.

S&P Dow Jones will remove Trade Me Group Limited from the S&P/ASX 200 effective at the open of trading on May 3, 2019. Trade Me Group Ltd. will be replaced by NRW Holdings Ltd. (XASX: NWH) in the S&P/ASX 200 effective at the open on May 3, 2019.
